Meeting of Tuesday, September 13th, 2022 5:30 p.m.

The Board of Trustees of the Wabash Carnegie Public Library met in a regular session at 5:30 p.m. on Tuesday, September 13th, 2022. NEW BUSINESS

New Hires

Ware Wimberly reviewed his recommendations for new hires to staff positions. His first recommendation was to hire Peighton King as the full-time Assistant Technical Services Manager beginning September 16. His second recommendation was to hire Madelyne McCann and Ashley Mosley as part-time Circulation Assistants. The trustees approved the recommendations.

Advertise 2023 Budget

The trustees reviewed the proposed budget for 2023 and approved advertising it. Because the library's General Obligation Bond put the 2023 budget above the approved five percent growth quotient, and because the library's trustees are appointed and not elected, the budget has to be approved by Wabash City Council which is the elected fiscal entity that oversees the library. The budget's public hearing will be at the City Council's September 26, 2022, meeting and its adoption will be at the City Council's October 10, 2022, meeting.

Action: Susan L. Baker moved, and Rhonda Hipskind seconded the motion to advertise the proposed 2023 budget. Motion passed.
